Board of Fish Concludes 2012 Cycle

Over the course of two months, the Alaska Board of Fisheries considered regulatory proposals for everything in Southeast from use of bait for kid, to king crab fisheries. The ATA board and staff spent weeks in Ketchikan, defending the fleet's interests against such things as fixed 7 and 10 day troll closures, and initiatives that could threaten wild Chinook stocks. ATA also worked to secure a few new things, like the ability to keep coho on June 1; better access to Taku River Chinook; late year access to hatchery coho; a new area for trollers to target hatchery chum; and improved lingcod allocation. As usual, the meeting involved some compromises between gear groups and produced a few solid wins, along with a few disappointments.


Proposal 312, submitted by USAG, sought to impose a 7-day closure in July and an automatic 10-day closure in August. The data showed that the proposal would do little to improve conservation or move fish to the gillnet fleet. At the meeting, USAG asked ATA to withdraw a proposal to extend coho to Sept. 30th, in exchange for them withdrawing 312. It was a tough decision, but the board felt that it was most important to make sure that 312 was stopped in its tracks. The only way to guarantee that was to get it off the table. The deal was cut. Hopefully the gillnet leadership will avoid such divisive ploys in the future - the industry needs to work together, not tear itself apart.

While we were unable to change the troll season end-date to Sept. 30, ADFG worked with us to modify regulatory language and clarify the management objectives for an extension. This could allow extensions to occur more often. The Board of Fish also approved ATA's proposal to keep coho June 1. Due to the time needed to process the large volume of new rules, this provision might not be in place by June 1st. However, ADFG has committed to implement the regulation as soon as it's legal, so pay close attention to spring news releases.

Proposal 325 got lots of attention. ATA worked with chum trollers to secure a new test fishery targeting DIPAC chums near Juneau. The area will be heavily restricted while ADFG analyzes impacts, so if you fish there make sure you understand the rules. Other Juneau area proposals didn't work out as well, and trollers were again denied equitable time and area to harvest Taku River kings.

Proposal 310 passed and will allow hatchery fish to be added to the winter cap. This will make a difference mostly in years that the fishery exceeds 45K. While respecting that some trollers disagree, ATA opposed 310 based on a long history of troll management and implications for the summer fishery. ATA supports continuing to insulate the winter fishery from treaty quota cuts, but has to balance this with previous Board of Fisheries mandates to lengthen the summer fishery to 20 days. Since Chinook Task Force days, the fish saved in winter and spring have accrued to the summer to help achieve that goal. We are discussing this history at spring port meetings and ATA's comments on the proposal are posted on the Board of Fisheries website, which you can link to from our homepage. Troll issues are often deeper than they appear and there are a lot of opinions out there. Call with any questions or feedback. The Board takes seriously the job of trying to balance the needs of all sectors of our fleet.

2011 Chinook Mitigation Projects Underway

Congress authorized \$15 million to help mitigate the impacts of Chinook quota reductions under the 2009 Pacific Salmon Treaty agreement. The state targeted the funds at troll and sport interests, since our user groups are most affected by the quota cuts, but many of the projects will benefit other harvesters and the communities. A Stakeholder Panel of troll, processor, sport, community, and native representatives works cooperatively to identify project recommendations for the Governor's Fish Cabinet, which makes the final decisions. ATA selected the troll representatives: Steve Merritt (C'est La Vie), Howard Pendell (Rosalee), and Dale Kelley (ATA). Rich Davis (Westbank) represents processors. In 2011, mitigation monies went to direct payments for trollers; troll and sport infrastructure; and, enhancement. The state has been quite generous about waiving or reducing its administrative charges, leaving the maximum amount available for the mitigation program. ATA is working now to identify mitigation requests for 2012. The following is a recap of the 2011 program:

Direct Payments: \$1.5 million was distributed to 1,345 qualified troll permit holders based on a 3-tier program. Distributions under Tiers 1 & 2 were apportioned between licensed hand and power trollers and the payouts totaled \$162,975 and \$476,550 respectively. Tier 3 was based on individual 2009 landings in round pounds, and paid about 50 cents per pound for a total of \$860,475. While a direct pay program is on ATA's working list for round two, it could be difficult to secure again. ATA recognizes that these payments do not fully mitigate the fleet, and we would all rather have the opportunity to catch a fair quota. That said, this money has been a nice shot in the arm for folks who have been belt tightening for many lean Chinook years. If you appreciated this program, send the ATA office a short thank you to Governor Sean Parnell. Email your letter and a picture and we'll merge and deliver it for you. Thanks to those who already made time to write!

Enhancement: \$2.4 million was dedicated to increasing production of Chinook and coho salmon. Unfortunately, very few options exist to safely and economically produce more of those species, so funds were mostly aimed at facility upgrades to improve rearing conditions and try to get more fish from existing programs. Money was also set aside to improve the methods used to estimate Alaska hatchery Chinook.

Infrastructure: \$2.6 million was spent to fill gaps in troll and sport services around the region. All projects are underway. The City of Pelican ice house is particularly important to support the north-end fleet and processors. We are happy to report that after a long and convoluted process, the city was able to gain site control and now has a running start on the project. Looks like we'll have to be patient for a few more months, but we are confident the good people of Pelican will someday soon be able to fill ice orders. Also good news is that the City of Craig is nearly finished with its ice improvements and word is the ice looks great.

Chinook Mitigation 2012

The Stakeholder Panel meets in early May to develop recommendations for the Fish Cabinet. ATA's list of projects is evolving and a few are noted below. The Board is reviewing several more options, and new ones may emerge during negotiations. ATA's prime goals are mitigating those fishermen most affected by Chinook cuts and broadly distributing benefits throughout the region. Project timing is likely to mirror last year's. If we are able to secure a direct pay program, applications will probably be sent out in the fall - so heads up! Details and updates on the mitigation program can be found on ADFG's webpage - link to it from www.aktrollers.org. Here is ATA's *preliminary* mitigation list:

Direct Payments to Trollers

- **A.** Secure one-time recovery grant for those trollers who were qualified for the 2009 program, but did not receive payment. **Cost: \$115,000.**
- **B.** Reserve the bulk of the troll portion of the fund for direct payments as follows:
- 1. Multiple year payout for trollers who fished kings in the summer of 2010, 2011, or 2012 (e.g. 2011 check was based on 2009; 2012 check would be based on 2010; 2013 based on 2011).
- 2. Two-part formula to calculate individual payments for each of the three years:
 - **a. Flat Rate Component:** 75% split amongst troll permit holders who landed at least one king salmon during the summer fishery (July 1-Sept 30), paid at a 3:1 ratio [Power (3) to Hand (1)] for each year you qualified.
 - **b. Poundage Component:** 25% will be split amongst troll permit holders <u>based on their actual king salmon landings (calculated in round pounds) during the summer fishery (July 1-Sept 30)</u>, for each of the years you gualified.

Remember, NO decisions have been made yet, and there's a long way to go. When the process is complete and the state approves a plan, information and details will be posted on the ADFG and ATA websites.

Killer Whales, Chinook Salmon, and YOU?!

Southern Resident Killer Whales (SRKW) are listed as 'endangered' under both the US and Canadian versions of the Endangered Species Act. Of particular concerned is the 'L' pod, which is considered resident to Puget Sound. The population isn't growing as fast as NMFS and DFO would hope, and some whales appear to be in poor condition, causing the agencies to question nutritional factors. Some believe that the SRFW rely almost exclusively on Chinook salmon and they are investing heavily in researching this hypothesis.

Three invitational workshops were set up by NMFS to present study findings, the last will be held in September. Dale Kelley attends the workshops. ADFG staff include the Deputy Commissioner and his assistant; the co-chair of the Chinook Technical Committee; and two former employees on contract to ADFG for treaty and related issues. They are well-respected scientists and are challenging suspect data and making presentations to the Expert Panelists, who are there to evaluate the data quality and assumptions presented.

Significant challenges face SRKW and most have nothing to do with a lack of Chinook. NMFS allowed nearly 70 animals, which would be breeding now, to be selectively taken out of the population in the late 1960's for aquarium use. SRKW are subject to intensive vessel traffic in Puget Sound and the Salish Sea; and, it is known that pollution has led to a build up of toxins in many of the whales. The military has a bomb test site off the Olympic Peninsula and there are many questions about healthy looking whales found dead of traumatic injuries in that area. Regardless, these workshops focus only on Chinook salmon. If NMFS concludes that fishing is affecting killer whales, this will become a significant issue on many levels; it is already creating tension at Treaty. ATA must be engaged and ready to act if NMFS' conclusions are unfounded and/or unreasonable.


